<u>Public Hearing- Preliminary and Final Plat – Commerce Properties LLC:</u>

Public Comment: None

Presenter: Eagle Rock Engineering stepped forward and stated the two conditions the public works dept. and fire dept. had asked for: fire hydrant and eliminate 2 parking spaces at the north end of the development at the intersection have been made.

lone Hansen: stepped forward stating the development agreement had the two changes in it along with the contingent condition that if and when the county/city improved 400 N they would pay their respective share of the costs.

#### Council Discussion:

Councilwoman Harrison asked what would prevent the developer from selling the lots inside the development to a different party who and how would the cost of improving 400 North be enforced? The attorney stated it would be best to add that condition to the plat as well as on the deed of each parcel.

### Multi-Jurisdictional Mitigation Plan:

Rebecca Squires Jefferson County Emergency Manager was requesting the city update its 5-year-old mitigation plan. With the plan being updated it will enable the city to participate in the federal program to mitigate infrastructure and community wide hazards.

Councilman Espinosa moved to sign the letter of intent to participate in the planning process for the county mitigation plan, seconded by Councilwoman Harrison.

The mayor called for a voice poll: all in favor none opposed.

#### <u>Anytime Fitness – Wellness Program:</u>

Beth Cammeron from Anytime Fitness approached the city about having the city participate in their corporate wellness program. There were two plans being offered: Silver Plan and Gold Plan. The two plans \$50/per employee or \$75/per employee is aimed at encouraging the employees to live a healthier life style. The 8-week or 12-week program conducts body mass scans and provides nutritional and

physical activity. Chief Fullmer indicated he felt his department would participate as did Brittney Fielding from the library and Mitch Bradley.

The mayor stated he had walked on behalf of Blue Cross and they contributed \$1,000 to the city which could go towards the cost. The council wanted to let the employees know of the plan and to find out the number of employees who would participate.

### Elevator Upgrade:

Brittney Fielding from the library reported the elevator at the library is having issues and in need of much needed upgrade. The cost of upgrading is \$79,241.24. The elevator also needs a 5-year recertification at a cost of \$3,963.44. TKE has presented an option for the city. If the city were to enter into an agreement for the upgrade the fee to re-certify would be waived.

The council discussed the use and need to have the elevator. The clerk stated that he had budgeted \$80,000 for the elevator in both the library fund and the capital improvement fund.

Councilman Howe moved to approve the work order for the upgrade at a cost of \$79,241.24 and waive the re-certification fee funds to be paid from the capital improve fund seconded by Councilwoman Harrison.

### Review of Bid Proposals for Rodeo Ground Grandstand:
